After your 9th attempt on the 3rd day, your Authorized Signatory (AS) will need to determine if obtaining a SIDA badge is in your best interest. If your AS still wants you to obtain a SIDA badge, you must complete the fingerprinting process again, pay an additional fee, and await new clearances. You will be given 3 more attempts.
